Personal data that Anamet Europe B.V. processes

If you only visit our website, we do use cookies, but the data we store with this are always anonymous. View our [cookie policy](#). We only process your personal data after you make use our services and/or because you yourself provide this information to us, for example to receive our newsletter. Below is an overview of the personal data that we may process, depending on the product or service that you purchase:

- First and surname
- Gender
- Company Name
- Business address details
- Business Telephone number
- Business email address
- IP address
- Location data
- Information about your activities on our website
- Other personal data that you actively provide yourself

Anamet Europe B.V. does not process special and/or sensitive personal data

Our website and/or service does not intend to collect data about website visitors who are below the age of 16 years. Unless they have permission from parents or guardians. However, we cannot check if a visitor is older than 16. We encourage parents to be involved in the online activities of their children, in order to prevent data about children being collected without parental consent. If you are convinced that we have collected personal information about a minor without this permission, please contact us via sales@anamet.nl and we will delete this information.

Anamet Europe B.V. does not collect special personal data such as data on religious beliefs, political opinions, ethnic origin, health or sexual orientation.

For what purpose Anamet Europe B.V. processes personal data

We process personal data for the following purposes:

- To be able to process the payment after you have purchased a product or service.
- To be able to call or e-mail you if this is necessary to perform the service that you have purchased.
- To inform you about (changes to) our services and products that you have previously purchased.
- To send the newsletters and mailings for which you have registered. For this you can always unsubscribe via a link in the mail.
- To tune our range of products and services to your preferences based on your surfing behavior. We only do this with your permission.

Automated decision

Anamet Europe B.V. does not make decisions based on automated processing (algorithms) that can have adverse consequences for you.

How long Anamet Europe B.V. retains personal data

Personal data may not be kept longer than necessary. The storage period depends on the purpose for which we have received or collected the data and any legal obligations to retain data. If you have any questions about this, you can contact sales@anamet.nl.

Sharing personal data by Anamet Europe B.V. with third parties

We share your personal data with business partners and third parties if this is necessary for the execution of the agreement and to comply with any legal obligation. We also provide your personal data to third parties in a few other cases, but we only do this with your explicit consent.

With companies that process your data in our order, we conclude a processing agreement to guarantee the same level of security and to safeguard the confidentiality of your data. We remain responsible for these processing operations.

Cookies, or similar techniques, that Anamet Europe B.V. uses

A cookie is a small text file that is stored in the browser of your computer, tablet or smartphone when you first visit this website. We use multiple cookies. View our [cookie policy](#).

On your first visit to our website we have already informed you about these cookies and we have asked you for permission to place them.

View, modify or delete data

You have the right to view, correct or delete your personal data. You also have the right to withdraw your consent to the data processing or to object to the processing of your personal data by Anamet Europe B.V. and you have the right to data portability. This means that you can submit a request to us to send the personal data that we

have from you in a computer file to yourself or another organization designated by you.

You can send a request for access, correction, deletion, data transfer of your personal data, or a request for cancellation of your consent or objection to the processing of your personal data, to sales@anamet.nl.

To ensure that the request for access has been made by yourselves, we ask you to include a copy of your ID with the request. Be sure to make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Citizen Service Number (BSN) black in this copy. This is to protect your privacy. We respond as quickly as possible, but no later than four weeks, after your request.

We would like to point out that you always have the opportunity to file a complaint with the national supervisory authority, the Dutch Data Protection Authority.

How Anamet Europe B.V. secures personal data

We take the protection of your data seriously and take appropriate measures to prevent misuse, loss, unauthorized access, unwanted disclosure and unauthorized modification. If you feel that your data is not properly secured or there are indications of abuse, please contact us at sales@anamet.nl.

We have taken the following measures to protect your personal data:

- Our employees' servers and devices are equipped with up to date security software, such as a virus scanner and firewall.
- We only send your data via secure internet connections (TLS, formerly SSL). You can see this at the address bar 'https' and the padlock.
- Access to personal data is secured with passwords.
